Russian Translator / Interpreter: (Grade-I): 07 (UR-4, OBC-01, SC-02)
(2-UR;01-OBC; 1-SC Posts are for Design Complex, Bangalore and remaining are for Nashik Division)

ELIGIBILITY

Russian Translator / Interpreter: (Grade-I):

Degree in Engineering / Technology or its equivalent + proficiency in Russian Language from recognized Universities / Institutes.

or

Degree in Engineering / Technology or its equivalent from Russian Universities provided it is recognized on par with Degree in Engineering / Technology or equivalent offered by recognized Indian Universities.

or

In case sufficient candidates with qualification as above are not available, candidates possessing 5 years Integrated Degree of Master of Arts in Russian Language (Translation & Interpretation) (Full Time Regular Course) from Recognized Universities / Institutes, will also be considered.

The UR/OBC candidates should have secure a minimum of 60% marks and SC/ST candidates should have secured a minimum of 50% marks, in aggregate, of all the semesters / year or corresponding CGPA ratings / Graduations in their Qualifying examinations.

AGE

Upper age limit is **35 Years** as on **01.09.2013**. The upper age limit is relaxable upto 03 years for candidates belonging to OBC (Non-Creamy layer) and upto 05 years for candidates belonging to SC & ST category. For candidates who had ordinarily been domiciled in the state of Jammu & Kashmir during the period from 1.1.80 to 31.12.89, the upper age limit is relaxable by 5 years. Relaxation will be extended as per rules in respect of Ex-servicemen/Commissioned Officers/ ECOs/ SSCOs who have rendered at least 5 years of service and have been released on completion of assignment.

REMUNERATION

The selected candidates will be paid a starting basic of Rs.12600/- in the scale of pay of Rs.12600 to 32500. Besides Basic Pay and IDA, the selected candidates will be eligible to get 44% of basic as Perks and Allowances along with other benefits such as PF, Incentive, Gratuity, Group Insurance, Leave encashment, etc.

HOW TO APPLY & APPLICATION FEE

The Application Format shall accompany the attested Xerox copies of certificates in support of Date of Birth, Educational Qualifications, Caste Category, Experience etc along with a crossed Demand Draft drawn in Favour of Hindustan Aeronautics Limited Payable at State Bank of India, Ojhar Township (SBI Branch Code : 1196) for ₹.500/-, which is non-refundable (SC candidates are exempted from the Demand Draft). Candidates are required to possess a valid **E-mail ID**, so that intimation regarding interview can be sent. HAL will not be responsible for bouncing of any E-MAIL sent to the candidates by E-Mail. However, from time to time necessary information will be hosted on HAL Web site.

SELECTION PROCESS

The selection process will comprise of Written Test and Interview. The Division will decide the Cut-off percentage for calling candidates for written test based on the marks secured in the qualifying Examination, based on the number of applications received. The Written test will be for 85 Marks and Interview will be for 15 Marks.. Candidates will be called for interview in the ratio of 1:5 (Maximum) categories wise for the Personal Interview, out of the candidates qualified in written test based on the merit. The call letter for interview will be sent by the E-mail provided by the candidates. Candidates will be paid traveling allowance as per the rules of the company for attending the interview only. The Written Test will be conducted at Nashik Only. The pattern of the written test will be intimated in the Admit card.

HEALTH

Applicants should be of sound health and should meet the medical standards prescribed by the Company. Appointment of selected candidates will be subject to receipt of satisfactory medical report from the Company's Doctor as per the Medical Standards of the Company.

GENERAL CONDITIONS

- Only Indian Nationals need apply.
- Age and Experience are to be calculated as on 01.09.2013.
- Mere submission of application will not entail right for claiming employment.
- Applicants serving in Government/Public Sector, Semi-Government Organizations should submit the application through proper channel / produce “No Objection Certificate” at the time of interview.
- Candidates who have Work – Experience in Private Sector Company / Organisation should produce their experience certificate in the letter head of the Company/ Organisation in which they have worked. The letter head of the Company/ Organisation should contain the details of the Company.
