#### **ELIGIBILITY**

## Assistant Officer (Security Services): (Grade-I):

- (i) Successful completion of ten months pre-Commission training course from the Officers' Training School, Madras or from any other equivalent Institution under the Defence Forces

  OR
- (ii) Successful completion of one / one and a half years course conducted by the Central/State Governments qualifying for appointment as Deputy Superintendent of Police/Sub-Inspectors in State Police, Railway Protection Force, Central Reserve Police, Border Security Force;

  OR
- (iii) Successful completion of one year training course conducted by Central Government for those selected for the posts of Intelligence Officers in the Central Intelligence Bureau and Research and Analysis Wing;

OR

- (iv) Successful completion of Training conducted by the central government for candidates selected for the post of Sub Inspectors in the CISF or successful completion of one year training conducted by Home Ministry, Government of India, for SI in CBI

  OR
- (v) 52 weeks training course of Instructions for IAF Police in the rank of Sergeant, Junior Warrant Officer, Warrant Officer and Master Warrant Officer
- (vi) Two years PG Degree (M Sc) in Forensic Science & Criminology acquired after (10+2+3) OR
- (vii) Two years PG Degree (MA) in the following Subjects, acquired after Graduation (10+2+3):MA Sociology/ Economics/ Psychology/ Public Administration/ Criminology/ Political
  Science/ Anthropology/ Human Rights/ Media Studies/ Social Policy/ Public Policy.

#### AGE

Upper age limit is <u>35 Years</u> as on **01.09.2013.** For candidates who had ordinarily been domiciled in the state of Jammu & Kashmir during the period from 1.1.80 to 31.12.89, the upper age limit is relaxable by 5 years. Relaxation will be extended as per rules in respect of Ex-servicemen/Commissioned Officers/ ECOs/ SSCOs who have rendered at least 5 years of service and have been released on completion of assignment.

#### REMUNERATION

The selected candidates will be paid a starting basic of Rs.12600/- in the scale of pay of Rs.12600 to 32500.Besides Basic Pay and IDA, the selected candidates will be eligible to get 44% of basic as Perks and Allowances along with other benefits such as PF, Incentive, Gratuity, Group Insurance, Leave encashment, etc.

#### **SELECTION PROCESS**

The selection process will comprises of Written Test and Interview. The Written test will be for 85 Marks and Interview will be for 15 Marks. Candidates possessing the qualifications indicated at Sl.Nos. (i) to (v) and who apply for the post will be called for Written Test. The Division will decide the Cut-off percentage for calling candidates (for the candidates who possess the Qualifications mentioned (vi) & (vii)) for written test based on the marks secured in the qualifying Examination, based on the number of applications received. Candidates will be called for interview in the ratio of 1:5 (Maximum) categories wise for the Personal Interview, out of the candidates qualified in written test based on the merit. The call letter for interview will be sent by the E-mail provided by the candidates. Candidates will be paid traveling allowance as per the rules of the company for attending the interview only. The Written Test will be conducted at Nasik only. The pattern of the written test will be intimated in the Admit card.

### HEALTH
