2. <u>PAY SCALE</u>: Rs. 10300-34800 + 5000/- Grade Pay

### 3. <u>ESSENTIAL QUALIFICATIONS</u>:-

- i) Should possess a degree in any of Engineering or in any discipline of Textile Technology or its equivalent from a recognized university or institution; Or
- ii) Should possess a diploma in discipline branch of Engineering or in any branch of Textile Technology or its equivalent from a recognized university or institution; and should have an experience of working in a Government Department, Public Sector undertaking or in a reputed industry after obtaining the requisite diploma, for a minimum period of five years; or
- iii) Should possess a degree of Master of Business Administration or post graduate degree in second division in Economics or Mathematics or Chemistry or Agriculture or Physics or Commerce or Statistics or its equivalent from a recognized university or institution.
- iv ) Punjabi of Matric or its equivalent standard.

Qualification of Punjabi is essential for these posts For this purpose a Matriculation or its equivalent certificate for having passed Punjabi will be necessary. (relaxable for Sikh Migrants upto the extent that they will have to acquire such qualification within two years after joining the service failing which their services shall be liable to be terminated).

<u>Important Note</u>: The candidates MUST possess the requisite qualification on or before <u>01-11-2013</u> (i.e. The Last date of submission of Online Application Forms.)

### 4. <u>AGE</u>

- (i) Candidate should not be below 18 years and above 38 years of age on 1-1-2013.
- (ii) Upper age limit may be relaxed up to 45 years for all States/ Central Government employees.
- (iii) The Upper age limit is relaxable upto 43 years for Scheduled Castes of all States and Backward Classes of Punjab only.
- (iv) Ex-servicemen of Punjab Domicile shall be allowed to deduct the period of his service in the Armed Forces of Union from his actual age and if the resultant age does not exceed the maximum age limit prescribed for direct appointment to such a vacancy in the Service Rules concerned by more than three years, he shall be deemed to satisfy the condition regarding age limit.
- (v) Upper age limit is also relaxable upto 42 years for Widows, Divorcees and certain other Categories of Women.
- (vi) Upper age limit is also relaxable upto 48 years for Physically Handicapped of Punjab.

### 5. <u>COMPETITIVE EXAMINATION</u>

The Commission shall hold a Competitive Examination, details of which shall be hosted on the Commission's website shortly.
