#### 1. EX-SERVICEMEN CANDIDATES:

The term Ex-Servicemen means a person : (a) who has served in any rank (whether as a combatant or non-combatant) in the regular Army, Navy or Air Force of the Indian Union but does not include a person who has served in the Defence Security Corps, the General Reserved Engineering Force, the Lok Sahayak Sena and the Para Military Forces and who has retired from such services after earning his/her pension or (b) who has been released from such service on medical grounds attributable to military service or circumstances beyond his/her control and awarded military service or other disability pension or (c) who has been released otherwise than on his/her own request as a result of reduction in such establishment or (d) the person serving in the Armed Force of the Union, who on retirement from service would come under the category of Ex-serviceman, may be permitted to apply for re-employment one year before the completion of the specific terms of engagement and avail themselves of all concessions available to Ex-Servicemen, but shall not be permitted to leave the Uniform until they complete the specified terms of engagement in the Armed Forces of the Union.
