The work relating to On-line filling shall involve three stages:-First Stage:- On the specified website of the Commission, the Candidate shall click 'Candidate's Registration' and fill in On-line information in the format and register himself. Thereafter the candidate shall print the Registration slip and take a copy of the same to preserve with him. The specimen of the Registration slip is available at the Appendix-3. Also, get an E-Challan print out of the State Bank of India or Punjab National Bank, the specimen of which are given at Appendix-4 and Appendix-5 respectively. This may be noted that at the next stage of filling the application the applicant shall be required to enter correctly the Registration Number at the specified space.
