(a)EducationalQualification:

- (i) Post Graduate Degree in the Specialty, recognised by MCI & having passed on or before 31-07-2013
- (ii) Post Graduate Diploma in the Specialty, recognised by MCI & having passed on or before 31-07-2013 (iii) SR-ONCOLOGY: Candidates should be MS/ Genl. Surgery.
