Interview for engagement of Part-time Dental Surgeon for four hours daily for Central Hospital, New Delhi will be held in the chamber of Medical Director, Northern Railway Central Hospital, New Delhi (Room No.32) on 3.10.13 at 11 AM. Eligible candidates are required to submit their application on the prescribed Performa on A4 size paper along with attested Xerox copies of relevant certificates so as to reach the office of "The Medical Director, Room No.26, Northern Railway, Central Hospital, Basant Lane, New Delhi-110055" on or before 26.09.13 by 16.00 hrs. Applications received after the closing date and time i.e. 26.09.2013 after 16.00 hrs will not be accepted. If applicants are large in number, administration holds the right to shortlist candidates for appearing in interview. Short listed candidates will be informed telephonically & through email.

**Eligibility criteria-**

1. Qualification and experience-Bachelor of Dental Surgery(BDS)from an institute recognized by Dental Council of India(DCI) with three years of working experience after completion of BDS or a post graduate degree(MDS).

2. Age limit-Less than 60 years during entire duration of contract.

**Documents to be produced at the time of interview**-The following documents should be produced at the time of interview in original.

(Xerox copies to be sent with application).

1. Completed application form along with two recent passport size photographs duly supported by a copy of valid Photo-ID proof.
2. BDS and MDS (if post-graduate) degree certificate.
3. Mark sheets of all years of BDS and attempt certificate.
4. Compulsory rotatory internship completion certificate.
5. Candidates must have a valid registration with Dental Council of India (DCI)/Delhi Dental Council (DDC)/State Dental Council. For candidates, not having registration with Delhi Dental Council will have to apply to DDC before joining. The proof regarding the same will have to be submitted at the time of joining.
6. Proof of age.
7. Experience certificate.
8. Certificate of good general fitness from a Registered Medical Practitioner.
9. Certificate of good moral character and antecedents from two Gazetted officers of Central/State Government.

**Note:-**In the event of wrong information/fake academic certificates/testimonials/mis-statements/discrepancy in the particulars being

detected at any stage, the candidature/service may be cancelled/terminated without any notice and necessary action as per extant law will be taken. No further correspondence will be entertained in this regard.

**Engagement will be guided by following rules:**

1. The engagement will be purely on contractual basis for a period of one year from the date of entering into contract and will not confer any right or claim on the person engaged for regularization/appointment/continuation in the Railways.
2. In case the working of person engaged is not found to be satisfactory or in case he/she is found to be mentally/physically incapacitated, the contract can be terminated by giving 15 days notice without assigning any further reasons whatsoever.
3. Working hours will be from 9am to 1pm on all working days except Sundays and gazetted holidays.
4. The Part-time Dental Surgeon will be paid monthly emoluments of Rs.19400/- as consolidated amount. No other allowances would be admissible for the period of contract. Proportionate deduction per day of absence is Rs.647/-.

No TA/DA will be paid for walk-in interview.

The person engaged will be required to sign a contract agreement to be executed by the person & can be seen at the time of walk in interview.
