Applications in the prescribed proforma appended hereto are invited from the candidates who are qualified and eligible as on the last date fixed for receipt of applications for recruitment to **3 (THREE)** posts of Drivers on the establishment of High Court of Karnataka.

2. Method of Recruitment:- Selection of candidates shall be made in accordance with the High Court of Karnataka Service (Conditions of Service and Recruitment) Rules, 1973, and the High Court of Karnataka Service (Direct Recruitment by Selection) Rules, 1984 as amended from time to time.

"By direct recruitment by selection of suitable candidates who possess licence in driving, as a paid employee, heavy vehicles or light motor vehicles, as the case may be, and who have got fair knowledge of English or Kannada".

3. Scale of Pay:- 11600-200-12000-250-13000-300-14200-350-15600-400-17200-450-19000-500-21000.

- **5. Probation:-** The period of probation shall be two years, subject to the rules prescribed in this behalf.
- **6. Age Limit:-** Must have attained the age of 18 years and must not have attained the age of:-
- a) 40 years in the case of a person belonging to any of the Scheduled Castes or Scheduled Tribes or Category-I of other Backward Classes.
- b) 38 years in the case of a person belonging to any of the Category-II (A) or II(B) or III (A) or III (B) of other backward classes; and
- c) 35 years in the case of any other person.
- **7.** Applicants when called for the Driving Test must appear at their own expenses, at the place fixed for such test.
- **8.** No person who attempts to obtain extraneous support by any means for his candidature from officials or non-officials shall be eligible for appointment.
- **9. Fee:-** A fee of Rs.150/- (Rupees One Hundred and Fifty) is prescribed for every application. It should be remitted by means of Crossed Indian Postal Order drawn in favour of the Registrar General, High Court of Karnataka, High Court Buildings, Bangalore 560 001, and the same should be submitted along with the applications. Fee once paid shall not be refunded under any circumstances. Scheduled Caste / Scheduled Tribe and Category-I candidates are exempted from payment of fees.

- **10.** (i) Candidates should submit their applications complete in all respects, together with attested copies of all the testimonials of educational qualifications etc., so as to reach the Registrar General, High Court of Karnataka, High Court Buildings, Bangalore 560 001 on or before 31.01.2013 [5.00 p.m.]. Envelope containing the application should be superscribed as "Application for recruitment to the post of Driver". Applications received beyond the time so fixed shall be rejected.
- (ii) In-service candidates shall submit their applications through their official superiors so as to reach the Registrar General, High Court of Karnataka, High Court Buildings, Bangalore 560 001, not later than the date and time fixed for receipt of applications.
- (iii) If the last date fixed for the receipt of applications happens to be a General Holiday, the next working day will be the last date for receipt of applications.
- **11. Application Form:-** Application in the prescribed proforma * should be filled in by the candidates in their own handwriting and must be accompanied by the self attested following documents, failing which their applications will be rejected:-
- a) Three Certificates of good character, one from the Institution in which he had last studied and two from respectable persons unconnected with his school and not related to him testifying to his character (true copies).
- b) True copies of educational qualifications if any.
- c) Copy and Driving License (Copy of Complete Driving Licence).
- d) Crossed Indian Postal Order for Rs.150/- (Rupees One Hundred and Fifty) only drawn in the favour of Registrar General, High Court of Karnataka, Bangalore.
- e) Persons claiming the benefit of reservation under Scheduled Caste Category and other backward class category and shall produce a Certificate in the form prescribed, issued by competent authority.
- f) True copy of the Certificate showing the date of birth of the candidate.
