#### 7. **HOW TO APPLY**:

- i. Candidate should carefully read all the instructions given in the employment notification before filling the application form.
- ii. Application should be submitted on a good quality white plain A4 size paper in the format given as Annexure-I in the Employment notice.
- iii. The application should be filled in with capital letters either in English or Hindi only.
- iv. The application form should be filled by the applicant in his/her **own handwriting** using a blue or black ballpoint pen only.
- v. Serving Government employees should send their applications through proper channel duly forwarded by their controlling official. The last date will not be extended on account of delay in transmission of the application by the concerned office. However an advance copy of the application can also be submitted.
- vi. Candidates belonging to SC/ST/OBC community shall submit their attested Photo copies of community certificates as issued by the appropriate State Government authorities.

#### 8. WHOM TO ADDRESS:

- i. The filled in application form along with its enclosures should be sent by ordinary post only in a cover addressed to 'The Dy.Chief Personnel Officer/Admn. & Rectt., Office of the Chief Personnel Officer, 4<sup>th</sup> floor, Rail Nilayam, Secunderabad 500 071'.

- iii. The applications shall reach this office on or before closing date. Applications received after closing date will not be entertained. South Central Railway will not be responsible for any postal delay or wrong deliveries.

# 9. Application Fee: Rs.40/- (Non-refundable)

- i. Mode of Payment: To be paid in the form of a crossed Indian Postal Order (IPO) (purchased on or after the date of publication of the employment notification) or crossed Demand Draft drawn in favour of 'FA & CAO, South Central Railway' payable at Secunderabad/Hyderabad.
- ii. For General/OBC candidates: Rs.40/-
- iii. For SC/ST(\*) Minorities, (\*\*) Economically backward classes, women candidates: NIL
- Note: (\*) Minorities shall mean Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis)
  - (\*\*) Economically backward classes (EBC) will mean the candidates whose family income is less than Rs.50,000/- per annum. The following authorities are authorized to issue income certificate for the purpose identifying the economically backward classes:
  - i. District Magistrate or any other Revenue Officer up to the level of Tehsildar
  - ii. Sitting Member of Parliament of Lok Sabha for persons of their own constituency
  - iii. BPL card or any other certificates issued by Central Government under a recognized poverty alleviation programme of Izzat MST issued by Railways
  - iv. Union Minister may also recommend for any persons from anywhere in the country
  - v. Sitting Member of Parliament of Rajya Sabha for persons of the district which these MPs normally reside. The income certificate issued by the above authorities shall be issued on the letterhead of the issuing authority.
- 10. **Examination Centre**: The written and other tests will be conducted at Secunderabad/ Hyderabad.
- 11. Mode of selection & Recruitment process:

The candidates, who apply in response to the notification issued and are found eligible for consideration for appointment against Scouts & Guides quota shall be assessed on the following basis:

A) Written test 50 MARKS

The written test will consist of 50 objective type questions relating to Scouts and Guides organization and its activities as per syllabus mentioned in the notification.

# B) Scouts/Guides qualifications over and above the minimum prescribed as eligibility Condition

35 MARKS

- a) Participation in International event one event 5 marks two or more events 7 marks
- b) Participation in National Events/ National Jamboree (No marks for the first event. The same being the minimum eligibility condition First additional event 5 marks, two additional events or beyond 7 marks) 7 marks
- c) Participation in Jamboree on the Indian Railways (one event 5 marks, two or more events 7 marks) 7 marks
- d) Events/Rallies attended at state level (one event 5 marks two or more events 7 marks).

e) Specialised Scout/Guide course Pioneering/ Mapping and standard judging course / vocational craft course (one course 5 marks two or more courses 7 marks).

## (C) Personality test/Interview

15 MARKS

The final empanelment to the tune of the notified vacancies will be based on the final merit order prepared based on the marks obtained by the candidate in the written test, personality test/interview and the marks assigned to the Scouts/Guides qualifications etc.

## 12. **Syllabus**:

History of Scouting/Guiding Law and Promise Organisation Distt. and State Level, Training Center – Distt. and State level knowledge of Books, Scouting for Boys/Guiding for Girls in India, Motto left hand shake, Salute, prayer, Flag Song, National Anthem, know the National and Scouting Flags, Social Services at various occasions, Hiking, Proficiency Badges. How these are earned. Stages in Scouting/Guiding. Thinking Day Progressive Training of Scouts/Guides/Rovers/Rangers; Pioneering. Handicrafts, Indian Railway/Jamboree, National Jamboree, Jamboree on the Air.

Organisation at National level, National Training Centers WAGGGS/WOSm-Uprashtrapati Award Competition; Prime Minister Shield Competition, Community Development programmes, Aims and Methods of Scouting, How Scouting is useful in producing better citizens?

## 13. General conditions of Recruitment:

- i. Merely satisfying the age and educational qualifications itself will not constitute a right to be called for written examination unless the candidate fulfills all other conditions laid down in this employment notification.
- ii. Before applying, the candidate should ensure that he/she fulfills all the eligibility norms. The candidate should possess the requisite qualification for the post applied for at the time of applying itself. Candidate acquiring the qualifications after the date of application shall not be eligible.
- iii. Candidates attempting to give false information/suppressing the facts will be disqualified and are liable for debarment and for legal action. Candidates who attempt fraud/impersonation are liable to be debarred for life from appearing in any examination conducted by this Railway.
- iv. Candidates recommended for appointment will have to pass the prescribed medical examination conducted by the Railway administration before appointment.
- v. Mere selection of candidates and recommendation for their appointment shall not confer any prescriptive right on the candidates for their appointment in Railways.
- vi. Free sleeper class pass from the nearest Railway station indicated in the application form will be issued to the candidates belonging to SC/ST communities whenever they are called for at any stage of recruitment.
- vi. Canvassing in any form shall disqualify the candidate.
- vii. The candidates should be in readiness to appear for the written test at short notice after the last date is over.
- viii. Railway Administration is not responsible for any postal delay.

- iv. Attested Photo copy of community certificate (by the candidates belonging to SC/ST/OBC candidates)
- v. Attested Photo copy of 10<sup>th</sup> class certificate as proof of date of birth
- vi. Income certificate (in case of EBC as per Annexure mentioned in the notification)
- vii. Serving employee and staff of Quasi administrative offices of Railway Organisations: 'No Objection Certificate' and 'Bonafide Certificate' giving length of regular service etc. from the employer should be attached.
- viii. Divorced/Judicially separated women: Copy of Decree from the competent court of Law for having divorced/judicially separated along with an Affidavit that she has not remarried since should be enclosed.
  - ix. Widow: Death certificate of her husband together with an Affidavit that she has not remarried since should be enclosed.
  - x. Ex-Servicemen: Discharge certificate should be enclosed.
  - xi. Persons with Disability: Disability certificate issued by Medical Board of the appropriate Government in the prescribed format should be enclosed.

Applications not in the prescribed format, incompletely filled or filled/submitted in contravention of the above mentioned instructions will be summarily rejected.
