### 1 Eligibility:

- The candidate must be a citizen of India.
- He /She should be graduate in any discipline from a recognized University/Institution with knowledge of computer operations.
- He /She should possess minimum 3 years' experience in any Nationalized Banks or 5 years' experience in Private Sector Banks / HFC's /similar financial institution.
