Applications on the prescribed form available on the University Website www.kashmiruniversity.net are invited from the permanent residents of Jammu and Kashmir State for two posts of Production Assistants (UGC Non plan posts) in the Pay Band of Rs. 9300-34800 with AGP of Rs.4200/- available in the Educational Multimedia Research Centre (EMMRC). The applications should reach the office of the undersigned latest by 1st July 2013.

Qualifications:

"Master's Degree in any subject or Bachelor's degree in engineering with one year experience in Video production or Masters in Communication or equivalent degree with specialization in production.

The Application Forms should be accompanied by a Bank Draft of Rs.500/- drawn in favour of the Registrar, University of Kashmir payable at J&K Bank Hazratbal, Srinagar. *The detailed advertisement notice is available on the University Website.*

Other terms & conditions:

- iv. Eligible candidates shall have to appear in the written test for purpose of short listing in case of large number of candidates;

- vi. Candidates to be called for interview shall have to produce original documents relating to their age, qualifications & experience etc at the time of the interview.
