- 4. The Post(s) in this advertisement is/are whole time and private practice of any kind is prohibited.
- 5. Separate application should be submitted for each post along with the prescribed fee for each post. Single consolidated application for more than one post will not be considered.

GENERAL CONDITIONS

- 1. The aspiring applicants satisfying the eligibility criteria in all respect can submit their ONLINE application. The On-line application(s) will be available on AIIMS, PATNA web site www.aiimspatna.org w.e.f 21.08.2013 to 20.09.2013 (5:00 P.M).
 - (i) MINIMUM ESSENTIAL QUALIFICATIONS: All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for various posts. No enquiry asking for advice as to eligibility will be entertained.
 - (ii) DATE FOR DETERMINING THE ELIGIBILITY OF ALL CANDIDATES IN EVERY RESPECT SHALL BE THE PRESCRIBED CLOSING DATE FOR SUBMISISON OF ONLINE RECRUITMENT APPLICATION.
 - (iii) The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. If the candidate is not being called for interview, the reason for the same will be notified through the official website of AIIMS Patna.
 - (iv) Relaxation of Upper Age Limit: Age relaxation of 5 years for SC/ST, 3 years for OBC candidates. In the case of Orthopedic Physical Handicapped (OPH*) candidates, age relaxation up to maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates is admissible.
- 2. For filling up of Online application, candidates must have the following pre requisites ready
 - Valid e-mail ID
 - Scanned Passport size photograph (in JPG format sized less than 50kb.)
 - Scanned signature of the candidate (in JPG format sized less than 30 kb.)
 - Online payment of the required application fee
- 3. Individual application and application fee is required to be submitted/remitted for each post(s) (in case of candidates applying for more than one post).
- 4. Submission of On-line Application will be terminated by <u>05:00 PM on 20.09.2013</u>. The candidature of such applicants who fail to complete the online application and submission of completed application by the stipulated date and time will not be considered and no correspondence in this regard will be entertained.

- 5. Eligibility criteria: Appended as Annexure I of the Advertisement.
- 6. Application Fees (Non Refundable):

Payment should be made only through online payment mode. Payment through any other medium will not be accepted.

Note: The Physically Handicapped candidates (>40% disability) are not required to deposit any fee.

Preview of the candidate Photo and Signature must be clearly visible to candidate, if photo/signature image is coming small or not visible in preview on website online then it means photo/signature is not as per the AIIMS, PATNA prescribed format and your application will be rejected. So, be careful while uploading your photo and signature. Both must be visible clearly on Registration Form.
- 8. Short Listing: Based on bio-data, the Search cum Selection Committee may short-list candidates for interview. <u>Candidates called for interview will have to produce printout of their submitted application, payment receipt and all relevant original documents (along with duly attested copies of the same) in proof of details furnished in their application at the time of interview.</u>
- 9. Requirements for Deputation or Transfer:
 - a) Persons holding analogous post on regular basis with minimum five years of service in the immediately preceding Grade Pay and possessing the required qualification & experience.
 - b) Documents to be submitted at the time of Interview:
 - Vigilance Clearance Certificate, Integrity Certificate and Last Five years APARs.
 - NOC from the employer /parent department.
 - c) Upper age limit for transfer/deputation is 56 years.
 - d) Period of deputation: shall not normally exceed 3 years at a time. The pay of the Deputed Faculty Members will be protected as per Government of India Rules.
 - 10. The Place/venue for Interview will be Patna ONLY. No TA/DA is admissible for appearing in the interview. The schedule of interview will be intimated to the short listed candidates via the registered email and mobile phone number(s) and notice through the official website of AIIMS Patna, www.aiimspatna.org.
 - 11. Candidates applying under any of the reserved category viz. SC/ST/OBC will be considered subject to submission of Caste certificate on a prescribed format issued by the competent authority.

- 12. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by competent authority. The period of Probation applicable to all posts in this advertisement shall be of 2 years.
- 13. The numbers of vacancies are provisional and subject to variation. The Director, AIIMS, Patna reserves the right to vary the number of vacancies including reserved vacancies.
- 14. Those who are in regular employment must submit a "NO OBJECTION CERTIFICATE" from the employers at the time of Interview.
