- 2. The above positions are initially upto 31st March, 2014 and further extendable on yearly basis based on continuation of research project and subject to satisfactory performance of individual.
- 3. JRFs have the option to get them registered for the award of Ph.D. Degree with any University / Institute.
- 4. The upper age limit is 35 years for RA and 30 years for JRF / TA / LA as on the date of interview (Relaxation: 5 years for SC/ST/PH/Woman and 3 years for OBC candidates).
- 5. The date for determining age/qualification and experience shall be the date of interview. The eligible candidates may appear before the selection committee for interview on the date and time mentioned above. Candidates must bring with them a duly filled application, with original & attested copies of mark sheets/certificates etc. along with a recent passport size photograph.
- 6. No TA/DA will be paid to the candidates for attending the interview.
