- I. Application Process:** Online Applications are invited from Indian Nationals in the prescribed format for the posts of Group B staff in Nursing College and Hospital, AIIMS Raipur on contract basis for 11 months only.

Essential qualifications, eligibility criteria for each post will be as mentioned below. Certificates / PG degrees recognized by MCI / Nursing Council of India are equivalent in the concerned subjects.

- II Application Fees:** Application fees for General/OBC candidates is Rs 600/-, fees for SC/ST candidates is Rs. **200/-**. Fees shall be paid through online transfer module only.

- III. Last Date of Application:** The on-line filling up of application form will start on 30.09.2013 and automatically close on **15.10.2013 at 5:00 pm.**
- IV. Annexures:** Photocopy of application form and the attested photocopies of the following along with the originals must be brought at the time of interview only.
1. 'No Objection Certificate – NOC' for those who are working in Central/State Government /Semi Government Autonomous Institutions from their respective organization.
  2. Degrees, Certificates, Mark -sheets, Age proof, Caste certificates and Experience Certificates etc.
- V. Age:**
1. Age limit refers to completed age as mentioned in eligibility criteria, in years as on 1<sup>st</sup> Jul 2013.
  2. Age relaxation of 5 years for SC/ST, 3 years for OBC candidates.
  3. In the case of Orthopedic Physical Handicapped (OPH\*) candidates, age relaxation up to maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates.

Short Listing:** Based on bio-data, the Search cum Selection Committee may short-list Candidates for interview or they may be asked to appear in a **written examination** in case of large number of applicants.
