- II. Out of two Assistant Professor posts in Community Med.& Family Medicine, one post is earmarked for Biostatistics and one post for Clinical Epidemiology respectively.
- III. The post of Additional Professor in ENT is earmarked for Audiology and Speech Language Pathology.
- IV. Age and all other qualifications will be counted as on last date of receipt of application i.e. 04<sup>th</sup> September 2013.
- V. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.

### **DETAILS**

- (A) APPLICATION PROCESS: Advertisement and online Application module is hosted at www.aiimsraipur.edu.in. Application can be filled online at www.aiimsraipur.edu.in. The printed copy of the on-line application and the attested photocopies of all relevant certificates along with the originals must be brought at the time of interview. The on-line filling up of application form will start on 05<sup>th</sup> August 2013 and will automatically close on 04<sup>th</sup> September 2013 at 5.00PM.
- **(B) APPLICATION FEE:** The application fees of Rs. 500/- (Rs.200 for SC/ST candidates) to be made for AIIMS Raipur payable at Raipur. Payment is to be made on-line. This fee once remitted will not be refunded.
- **(C) FROM OTHER INSTITUTES:** Those who are working in Central/State Government /Semi Government Autonomous body have to submit "**No Objection Certificate**" from their respective organization along with their application.
- **(D) ANNEXURES:** Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Caste certificates etc. may be annexed to the hard copy of the application to be produced in original along with photocopy for verification at the time of interview.

- **(E) AGE LIMIT:** Age limit should not exceed 50 years for Assistant Professor and Associate Professor and 58 years for Additional Professor and Professor. Age is relaxable for Government servants, SC, ST and OBC up to 5 years and in otherwise exceptionally qualified/deserving cases.
- **(F) SHORT LISTING:** Based on bio-data, the Selection Committee may short-list candidates for interview. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview.
- (G) SITE OF INTERVIEW: The interview may be held at AIIMS, Raipur or at New Delhi. No TA/DA will be paid for appearing in the interview.

## (H) ESSENTIAL QUALIFICATIONS

- a) For Medical specialty, a medical qualification included in the first or second schedule or Part II of the third schedule to the Indian Medical Council Act of 1956 (persons possessing qualifications included in Part II of the third schedule should also fulfill the conditions specified in sub section (3) of the Section 13 of the Act.).
- b) For dentistry, a recognized Dental qualifications included in Part I or Part III of the Schedule to the Dentist Act, 1948 (persons possessing qualifications included in Part I or Part III of Schedule should also fulfil the conditions specified in sub section (1) and (2) or (4) of Section 10 of the Dentist Act, 1948).
- c) Ph.D. or Equivalent in the Anatomy, Physiology, Biochemistry, Community Medicine, Pharmacology, Microbiology, Pathology, ENT, Psychiatry and related allied courses from recognized University in India for non medical candidates.
- d) The candidate must be registered with the state/Central Medical/Dental Council of India.
- e) A postgraduate qualification of an Indian University or equivalent degree recognized as such by the Medical/Dental Council of India as under:-

## (I) EXPERIENCE

- a) **Professor:** 13 years of Teaching/Research Experience after Qualifying degree (3 years as senior resident or equivalent + 10 years as faculty).
- b) **Additional Professor:** 9 years of Teaching/Research Experience after Qualifying degree (3 years as senior resident or equivalent + 6 years as faculty).
- c) **Associate Professor:** 6 years of Teaching/Research Experience after Qualifying degree (3 years as senior resident or equivalent + 3 years as faculty).
- d) **Assistant Professor:** 3 years of Teaching/Research Experience after Qualifying degree or 3 years as Senior Resident or equivalent.
- e) For Super specialists: 3 years pre MCh/DM degree residency will be counted as teaching experience.

## (J) PAY SCALE

- a) **Professor: Pay Band-4**: Rs.37400-67000 with Academic Grade Pay of Rs.10500 (Plus NPA for medically qualified candidates only) with the minimum pay of Rs.51600/- and AGP of Rs.10500/-. Plus usual allowances admissible to equivalent posts in Government of India. Up to 40% of posts of Professors will get Higher Administrative (HAG) scale subject to clearance of the prescribed process.
- b) **Additional Professor**: **Pay Band-4**: Rs.37400-67000 with Academic Grade Pay of Rs.9500 (Plus NPA for medically qualified candidates only) with minimum Pay being Rs.46000/- and AGP of Rs.9500/-. Plus usual allowances admissible to equivalent posts in Government of India.
- c) Associate Professor: Pay Band-4: Rs.37400-67000 with Academic Grade Pay ofRs.9000 (Plus NPA for medically qualified candidates only). ) with minimum Pay beingRs.42800/- and AGP of Rs.9000/-. Plus usual allowances admissible to equivalent posts in Government of India.
- d) **Assistant Professor**: **Pay Band-3**: Rs.15600-39100 with Grade Pay of Rs.8000 with a minimum of Rs.30, 000/- + NPA. (NPA for medically qualified candidates only) with provision to move to PB-4 after three years (Rs.37400-6700) with Grade Pay ofRs.8700/-. Plus usual allowances admissible to equivalent posts in Government of India.
- **(K) PROMOTIONS:** A teacher gaining requisite experience for the higher post can be granted promotion subject to the Rules and Regulations applicable from time to time in the Central Government Institutions/ AIIMS, Raipur.

## (L) TERMS & CONDITIONS

- a) Canvassing of any kind will lead to disqualification.
- b) The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- c) The appointment is full time and private practice of any type is prohibited.
- d) He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- e) The candidate should not have been convicted by any Court of Law.
- f) In case any information given or declaration by the candidate is found to be false of if the candidate has wilfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- g) Applications incomplete in any aspect will be summarily rejected.
- h) The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
