1. AGE LIMIT RELAXATION (AS ON 01.01.2013)

Ex-Servicemen who have put in not less than six months continuous service will be given relaxation in age limit to the extent of period of service plus three years as follows.

(i) For UR candidates 33 years + extent of military service + 3 years 38 years + extent of military service + 3 years (ii) For SC/ST candidates (iii) For OBC candidates 36 years + extent of military service + 3 years

2. ELIGIBILITY

Ex-Servicemen who have retired after putting in 15 years of service and have passed Army Class-I certificate or equivalent, are eligible to apply.

3. EXAM INATION FEE

No examination fee is applicable.

4. MODE OF SELECTION

The names of eligible candidates will be arranged on the basis of total length of military service and ex-Servicemen to the extent of vacancies will be called for verification of original documents. After verification of document, a final panel will be prepared from this list. There will be no Written Examination/Interview or Physical Efficiency Test.

5. MEDICAL EXAMINATION

The candidates, who are empanelled, will be subject to Medical Fitness Examination and as per medical classification/standard they will be further considered for appointment based on vacancies available for that medical category/standard of fitness only.

6. RESERVATION FOR SC/ST CANDIDATES

Ex-Servicemen belonging to the Scheduled Caste or Scheduled Tribe is selected, his selection shall be counted against the over-all quota of reservations that shall be provided for the Scheduled Castes or Scheduled Tribes in accordance with the orders issued by the Central Government from time to time.

7. FILLING UP OF APPLICATIONS

Eligible Ex-Servicemen should submit their applications in the format enclosed to the notification. Applications should be made on good quality A4 size (210mm X 297mm) white paper using ONE SIDE ONLY. Applications in any other format would be rejected. The applications should be filled in by the candidates in their own handwriting either in English or in Hindi and not in any other language.
