Junior Chemist	Candidate must hold a Post Graduation Degree in Chemistry/Graduation Degree in Chemical Engineering from any University established by law in India or a degree of a foreign University of Institution declared by competent authority equivalent to a Post Graduate Degree in Chemistry or Graduation Degree in Chemical Engineering of an University established by law in India.

**Note (1):-** The candidates appearing in the final year/semester or any back paper of Post Graduation Degree in Chemistry/Graduation Degree in Chemical Engineering may also apply provided that their result of final year/semester/or back paper is declared on or before the date fixed for written competitive examination and they acquire Graduation /Post Graduation Degree as above.

**Note (2):-** In case any candidate does not fulfill the requisite prescribed qualification on or before the date fixed for written competitive examination, his/her candidature shall be rejected out rightly even though he/she qualifies the written competitive examination conducted for recruitment.

**3. Age:-** The candidate must have attained the age of 21 years and must have not attained the age of 35 years as on last date of online submission of Application. Relaxation in age, wherever applicable, shall be given as per rules.

**4. Remuneration/Salary:-** Selected Candidates will be initially engaged as "Probationer Trainee" for a period of two years and during the period of Probation Training they will be paid fixed remuneration @ Rs. 11,100/- per month.
