Applications are invited from the eligible candidates for filling up of 03 (three) posts of Assistant Geologist on temporary regular basis in PB-2 of Rs. 9300-34800 plus grade pay of Rs.5000/- under Mines and Geology Department, Government of Sikkim.

CONDITIONS OF ELIGIBILITY.

1. *Minimum Educational Qualification*
 - a). *Master Degree in Geology from a recognized University.*
2. *Other requisites* :
 - (1) *Candidate must be in possession of either Sikkim Subject Certificate or Identification Certificate issued by the competent authority under relevant orders of the State Government.*
 - (2) *Should have valid Local Employment Card.*
 - (3) *Should be conversant with the customs and usages of Sikkim.*
3. *Duties of the post* : *As prescribed by the Controlling Authority.*
4. *Age* : *Should have attained the age of 21 years, but should not have exceeded 30 years as on 01.05.2014. The maximum age limit shall be relaxed upto 5 years in respect of candidates belonging to B.L., S.T., S.C. & 4 yrs. for MBC candidates and 03 yrs. for OBC candidates.*

The complete application form should reach the Secretary, Sikkim Public Service Commission, Old West Point School complex, Near Police Headquarter, Gangtok by hand or by post on or before 03:00 p.m. on 15.07.2014.

No application submitted after 03:00 p.m. on 15.07.2014 will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise. Application received after last date and also incomplete application forms without required documents will be summarily rejected.

Applicant claiming the benefit of reservation should submit certificate of SC/ST /BL issued by the authorized officer and for OBC /MBC issued by the Officer authorized under Notification No. 3/WD/95.Dated: 06.06.1995.

There will be a written examination and interview for the selection of suitable candidate. No TA/DA is admissible for attending the examination/ Interview.

Admission at all the stages of examination for which candidates are admitted by the Commission viz: Main (written) Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission.
