1. Eligibility Criteria

- i) **Land losers** whose land has been acquired for Konkan Railway line Project (Self / Sons / Spouse / Unmarried daughters / Grand sons/ Unmarried Grand daughters only) are eligible.
- ii) Other than Konkan Railway land losers, only ST candidates from Employment Exchanges with valid registration along Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg and Ratnagiri Districts of Maharashtra; Goa State; and Karwar, Udupi and South Kannada Districts of Karnataka) are eligible.
- iii) Employees/Trainees of Konkan Railway are not eligible

2. Educational Qualification

Minimum three years Diploma from a recognized Technical Board/ University in Electronics/ Applied Electronics/ Power Electronics/ Industrial Electronics/ Electrical..

Candidates appearing at and/or awaiting result are not eligible. Applications not accompanied with certificates of each year for above qualification will be rejected.

3. Age

The candidates should be within the age group of 18 years (minimum) and 35 years (maximum) as on 01/01/2015, there will be Upper Age relaxation of 5 years for SC/ST candidates and 3 years for OBC candidates.

4. Job Description

JE Electrical is a supervisor in electrical department. JE can be posted either station or Production Units. If posted in a station he will be in charge of the electrical installations of the station like bulbs, fan, pumps, generators etc. He will have technicians under him to actually do the job. Normally he will have a few small stations of a section under him, which means he has to travel to these stations. He has to carry out various inspections as per the rule and regulations for asserting the condition of assets. His duty involves working in day/night as per the requirement of the corporation.

Being in charge of the section he has to deal with the manpower posted under him. He has to prepare various records and registers as per the railway rules. Execution/supervision of the works. He has to undergo various training as directed. He shall have knowledge in computer for various day to day working.

Note: Female candidates may kindly note that the category involves duties which are arduous in nature and call for working in shifts on railway station at odd hours, at road side station and also away from headquarters.

5. <u>Mode of Selection</u>

Separate panel will be prepared for landloser candidates and other than landloser candidates. Priority for appointment will be given to landloser candidates and only after exhausting the panel of landlosers, the second panel (other than landlosers) will be operated depending upon the shortfall in the vacancies notified.

Based on the applications received, eligible candidates will be called for written examination. Those who qualify in the written examination will be called for scrutiny of documents as per merit order. Candidates with all clear records and as per merit will be called for prescribed medical examination. The selected and medically fit candidates will be provisionally appointed based on the merit position.

6. <u>Medical Examination</u>

The candidates will have to pass the prescribed medical examination as per railways standards to be conducted at the candidate's cost by Konkan Railway Corporation's Medical Authorities. The medically fit candidates will only be considered for recruitment in KRCL. No alternative job will be provided if a candidate selected for a particular category fails to qualify in the prescribed medical test of that category/post.

7. Posting

The selected candidates can be posted and transferred anywhere in the area of operation of Konkan Railway Corporation Ltd, including its project sites. However, the employees of Konkan Railway Corporation Ltd. are not eligible for transfer to other Zonal Railways.
