(c) Holder of Radio Telephony Restricted (A) Licence. (d) At least 10 years experience to (i) Conduct flight operations in conformity with existing regulations and with regard to flight safety; (ii) Maintain adequate liaison with the DGCA HQs & Regional Offices on flight operation issues; (iii) Monitor the quality and standards of operational documents and procedures. (e) Preference would be given to candidates well versed with Civil Aviation Requirements (CARs), having broad aviation / technical education and computer literate.
2.	Flight Safety Officer. (No. of post -1)	(a) Graduate with Physics & Mathematics. Or 10+2 or an equivalent examination with Physics and Mathematics from a recognized Board/ University and holder of Flying Licence. Or Aircraft Maintenance Engineering Licence. (b) At least 10 years Experience in (i) Aircraft Accidents/ incident investigation, safety audits and accidents prevention work Or (ii) A flight crew member preferably on Type of aircrafts operated by the State Govt.; Or (iii) Experience as Aviation Engineer. (c) Preference to candidate possessing experience to implement and control flight safety programme in a DGCA approved Aviation Organization with good presentation skills and computer literate.

Note:
