Applications are invited for the below mentioned posts. The last date for receipt of applications in the office of the Commission is 31.07.2014. Casa J.D. Fernandes Stationery Supplier, Printers & Book Binders, Opposite Municipal Garden, Panaji, are authorized to sell the prescribed application form @ ` 20/- per set. Candidate can also download and use the application form available at GPSC **website**. The Commission does not take the responsibility of supplying application forms by post. **Candidates should see the GPSC website for latest updated "Instructions"**.

2. Candidates shall note that the Application Fee is enhanced to ` 400/- for General Category Candidates and those for SC, ST, OBC, Physically Handicapped and Ex-serviceman, it is 50% of the Application Fee i.e. ` 200/-. The application form should be accompanied by an Indian Postal Order or Demand Draft for the amount equivalent to the application fee payable to **"The Secretary, GOA PUBLIC SERVICE COMMISSION"** payable at Panjim.

3. Incomplete applications in any manner are liable to be rejected summarily by the Commission.

4. The upper age limit shown against each post is relaxable upto 5 years for the candidates belonging to SC/ST, upto 3 years for candidates belonging to OBC, upto 5 years (total 10 years for SC/ST & 8 years for OBC in respect of posts reserved for them) to blind, deaf-mute and orthopedically handicapped person and upto 5 years for CFF. Age is also relaxable for Government Servants upto 5 years as per the instructions issued by the Government from time to time.

5. In case of non-availability of suitable candidates with the knowledge of Konkani, for the posts in professional colleges, Consultants in Directorate of Health Services and highly technical/scientific posts, this requirement can be relaxed.

6. Prescribed EQs are minimum & mere possession of same does not entitle the candidates to be called for interview. Where number of applications received is large, the Commission will short list the candidates to be called for interview as mentioned in the **"Instructions"**.

I. GOA MEDICAL COLLEGE

1. Lecturer in Radiology 2 posts (1 post 2nd time) (1 post 3rd time)

Scale of Pay: Rs. 15,600-39,100+6,600/-

Age: Not exceeding 45 years.

Educational & Other Qualifications:-

Essential: (i) A recognised Medical qualification included in the First or the Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in Section 13 (3) of the Indian Medical Council Act, 1956. (ii) Post Graduate degree qualification in the speciality concerned or equivalent. (iii) At least 3 years teaching experience in the concerned speciality as Senior Resident/Registrar/ Tutor/Demonstrator in a Medical College/Teaching Institution. (iv) Knowledge of Konkani.

Desirable: Knowledge of Marathi

2. Assistant Lecturer in Casualty 1 post

Scale of Pay: Rs. 15,600-39,100+5,400/-

Age: Not exceeding 42 years.

Educational & Other Qualifications:-

Essential: (i) A recognised Medical qualification included in the First or Second Schedule or Part II of the Third Schedule (other than Licentiate qualification) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of Section 13 of the Indian Medical Council Act, 1956. (ii) Knowledge of Konkani.

Desirable: (i) Registered for Post-Graduate Degree in concerned speciality. (ii) Knowledge of Marathi.

3. Assistant Head Occupational Therapist in Orthopaedic Surgery 1 post

Scale of Pay: Rs. 9,300-34,800+4,600/-

Age: Not exceeding 42 years.

Educational & Other Qualifications:-

Essential: (i) Degree or Diploma in Occupational therapy from a recognized University/Institution or equivalent. (ii) 3 years practical experience in case of Degree holders, and 6 years practical experience in case of Diploma holders in Occupational Therapy in a recognized Institution/Hospital. (iii) Knowledge of Konkani.

Desirable: Knowledge of Marathi.

II. DIRECTORATE OF ARCHIVES & ARCHAEOLOGY

4. Scientific Officer (Preservation)1 post

Scale of pay: Rs.9,300-34,800+4,600/-

Age: Not exceeding 42 years.

Educational & Other Qualifications:-

Essential: (i) At least Second Class Master's degree in Chemistry or Physics of a recognized University or equivalent. (ii) 3 years experience of research or teaching or work in a Govt. Records Office. (iii) Knowledge of Konkani.

Desirable: (i) Training in modern methods of rehabilitation & preservation of records. (ii) Research on paper ink, leather, examination of documents, use of insecticides and fumigants; practical experience & training in high class binding work in a responsible capacity. (iii) Experience in repair and / or preservation of records in a Government Records Office. (iv) Knowledge of Marathi.

Note: Qualifications relaxable at the discretion of the G.P.S.C. in case of candidates otherwise well qualified; in particular the qualifications regarding experience is relaxable in case of candidates belonging to Scheduled Castes or Scheduled Tribes for posts reserved for them.

Scale of pay: Rs. 15,600-39,100+6,600/-

Age: Not exceeding 42 years.

Educational & Other Qualifications:-

Essential: (i) A degree in Electrical Engineering of a recognized University or equivalent. (ii) Eight years experience as Electrical Engineer in a responsible post. (iii) Knowledge of Konkani.

Desirable: (i) Knowledge of Marathi.

Note 1: Qualification(s) regarding experience is/are relaxable at the discretion of the Goa Public Service Commission in case candidates(s) is otherwise well qualified.

Note 2: The Qualification(s) regarding experience is/are relaxable at the discretion of the Goa Public Service Commission in the case of candidates belonging to Scheduled Castes and Scheduled Tribes, if at any stage of selection, the Goa Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.
