Before applying candidates must ensure that they possess the above mentioned Physical Standards. Selection of candidates is subject to being found medically fit by the medical officer of the Company as per prescribed rules of the company.

III. SELECTION PROCEDURE

Eligible candidates for the post of Consultant and Specialist Doctors will be called for Interview. Information for Interview will be provided on our website www.sail.co.in.

Eligible candidates for post at SI No.3 to 8 will be required to appear in Written Examination. On the basis of their performance in the Written Examination they will be called for Interview. Information for Written test and Interview will be provided on our website www.sail.co.in.

IV. TRAINING & PROBATION:

Candidates selected at post SI No. 3 to 8 will be placed on training for a period of 2 Years which may be extended by another two years as per requirement. On successful completion of training period, they shall be regularized in S-3 Grade. After successful completion of Training, Candidates shall be placed under probation for 1 year.

V. EMOLUMENTS AND OTHER BENEFITS

The emoluments for the post of Consultant and Specialist Doctors will include basic pay, dearness allowance, non practicing allowance, perquisites and other facilities such as medical facility for self and family, provident fund, gratuity etc., as per rules of the company. In addition, House Rent Allowance will be paid only where company accommodation is not available.

Candidates selected at Posts SI No. 3 to 8 will be paid consolidated Pay of Rs. 10700/-pm during 1st year of training and Rs. 12200/-pm during the 2nd year of training. During the period of 2 year training Trainees will also get Medical facility for self, spouse and dependent children. Leave etc will be as per the Rules of the Company.

The emoluments for the posts at SI No. 3 to 8 on confirmation after 2 years of training will include basic pay, dearness allowance, reimbursement of local travelling expenses and other facilities such as medical facility for self and family, provident fund, gratuity, LTC, etc., as per rules of the company. In addition, House Rent Allowance will be paid only where company accommodation is not available.

VI. HOW TO APPLY:

Eligible and interested candidates would be required to apply online through SAIL's website: www.sail.co.in (Careers with sail). **No other means/mode of application will be accepted.**

Before applying the candidates should ensure that they fulfill all the eligibility norms. Their registration will be provisional as their eligibility will be verified only at the time of interview. Mere issue of admit card / interview call letter will not imply acceptance of candidature. Candidature of a registered candidate is liable to be rejected at any stage of recruitment process or even on joining, if any information provided by the candidate is found to be false or not in conformity with the eligibility criteria at any stage or if candidate fails to produce valid documentary proof in support of his eligibility.

Before registering their applications on the website the candidates should possess the following:

- b) Candidates should ensure that they possess requisite qualification at the time of applying.

SC/ST/PwD/Local DP/BSL Departmental candidates to possess Pay- in Slip of **Rs. 50/-** (Non-refundable) only as processing fee. The Pay in Slip (SBI Challan) is to be downloaded from the website after filling in the required details.
- e) Candidates should have latest passport size photograph as well as photograph of signature in digital form (.jpg or .jpeg only of less than 500 kb size) for uploading with the application form.
- f) Candidates are advised to read carefully instructions for online submission of application. The same will be available in the website itself.
- g) While filling on-line application the candidates must carefully follow all the steps. Incomplete application/application without fee/application not fulfilling any eligibility criteria will be rejected summarily. No communication will be entertained from applicants in this regard.

- j) The application being online, if during verification of documents prior to interview, it is found that the candidate does not possess the requisite eligibility criteria, he/she will not be allowed to appear for the interview.

VII. MODE OF PAYMENT OF APPLICATION / PROCESSING FEE

Payment through Pay-in –Slip

State Bank of India has been authorized to collect the application and processing fee, in a specially opened account (SBI Power Jyoti A/c No. 31877168126 maintained by at SBI sector 4, B.S.City branch), on behalf of SAIL/Bokaro Steel Plant. Candidate has to approach the nearby SBI branch with a printout of the "SBI Challan" which is available on the Application Registration Portal. The SBI Challan printed from the Portal only should be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the concerned branch of SBI will issue a unique Journal Number and a Branch Code of the branch collecting the money. This Journal Number and the Branch Code are to be filled up by the candidate during online registration. In case a candidate deposits the fee in a wrong account, or doesn't finally submit the application form with payment details, SAIL/Bokaro Steel Plant will not be responsible. There will not be any other mode of collection of application/ processing fee. **Also please note** that the candidate will have to bear the Bank charges of certain amount to be paid to the collection branch of SBI in addition to the applicable application/processing fee. The SBI branches will accept the fee during Banking hours upto the closing date of submission of online application. The candidates will be provided opportunity to verify their payment status after reconciliation on SAIL website and edit the payment details in case of wrong submission of Journal No. or Branch Code. *No request for editing the payment details and issue of Admit card after closure of edit option will be entertained in wrong submission cases and candidature will stand rejected.* Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility before paying the application/processing fee and to fill in the payment details carefully.

VIII. IMPORTANT
