Should have represented the Country in International events and should be representing the Country at present or should have won "Arjuna Award".

C. Educational Qualification as on 01st April, 2014.

For the post of "Single Window Operator" & "Officer Cadre"

At least a Bachelor's Degree in any discipline. The Bachelor's degree should be from any recognized university. Also, should have computer literacy.

#### 3. Recruitment Procedure:-

Candidates possessing requisite qualification will be called for interview. Since, the recruitment will be mainly on the basis of sports performance, suitable weightage will be given to sports achievements and younger age will be considered. Recruitment will be strictly on merit.

The Bank reserves the right to restrict the number of candidates to be called for interview. Mere fulfillment of qualifications will not confer any right on a candidate

to be called for interview. Candidates found suitable will be wait listed. Final selection will depend upon the verification of character, antecedents, medical fitness and verification of genuineness of the sports certificates produced.

# 4. Service Conditions:-

## a) Pay & Perquisites - Single Window Operator (Clerk)

Pay Scale:

Selected Candidates will draw a starting basic pay of Rs8,000/- per month (Inclusive of two additional increments admissible to graduates) in the scale of pay band Rs.7,200-400 / 3-8,400-500 / 3-9,900-600 / 4-12,300-700 / 7-17,200-1300 / 1-18,500-800 / 1-19,300 (20 Years)

#### Officers (JMG Scale-I)

Selected Candidates will draw a starting basic pay band of Rs.14,500-600/7-18,700-700/2-20,100-800/7-25,700

- b) Selected candidates will be initially posted at Bangalore.
- c) However, once the sportspersons quits his sports, or a decision is taken by the Bank he will be pooled into general stream of employees. Once they are released to General Stream of employees they have to comply with norms as applicable to other employees as per Govt. of India directives.

## 5. How to apply:

a) Applications (preferably typewritten on plain paper) should contain brief bio-data of the candidate as per the format given in the advertisement.

# 6) Last Date:-

Applications should reach the Bank's Office on or before 08-09-2014.

#### 7) General Rules & Regulations:-

- All educational qualifications should be obtained from a recognized university.
- ii) Candidates should satisfy themselves about their eligibility for the post applied for and the Bank shall not entertain requests from the candidates seeking advice about their eligibility to apply.
- iii) Those candidates appearing for interview should make their own arrangements for traveling/stay. However, the candidates belonging to SC/ST Category, to & fro second class train fare by shortest route or actual amount incurred by the candidate, whichever is lower shall be reimbursed on production of proof of iourney and Caste certificate.
- iv) Candidates already in Govt. organizations and public sector undertakings / banks, will have to route their application through their employer in terms of Govt. of India directives or produce a "No Objection Certificate" from their employer along with the application/ at the time of interview. However, before employment in Canara Bank a proper discharge certificate from the employer will have to be produced.
- v) The candidates selected for appointment are required to execute a bond for Rs.1.00 lakh undertaking to serve the bank for a minimum period of 10 years. The bond amount payable by the employee shall be reduced by Rs.10,000/-for every completed one year of service in the bank.
- vi) Canvassing in any form will be a disqualification.
- vii) In all matters with regard to the recruitment sports persons the decision of the Bank will be final and binding on the candidates and no correspondence shall be entertained in this regard.
- viii) Any resultant dispute arising out of this advertisement shall be subject to the sole jurisdiction of the courts situated in Bangalore only.
