### NOTIFICATION FOR Ph.D. PROGRAMME AND ENTRANCE TEST-2015

Applications are invited online from the intending candidates for Ph.D. Programme and Entrance Test under various faculties of the Sambalpur University for the session 2015 (Course Work to start from January, 2015) Online application facility will be made available in the University website: [www.suniv.ac.in](http://www.suniv.ac.in) beginning **25.08.2014**

- 1. Eligibility:** A candidate, who has obtained Master's Degree in any discipline of Sambalpur University or any other University / Institute recognized by this University or such Degree as may be considered equivalent for this purpose by this University with at least 55% (or equivalent grade), shall be eligible for admission into the Ph.D. Programme. However, candidates belonging to SC/ST category shall be given a relaxation of 5% marks at Master's Degree level. The examination (objective type) will be held on **26.10.2014 (SUNDAY)** at Sambalpur University campus, Jyoti Vihar. The subjects offered for the current session along with the present vacancy position is given below:

Anthropology(01), Physics(04), Mathematics(04), Chemistry(16), Environmental Science(01), Environmental Science & Engg.(01), Life Science(03), Microbiology(03), Biotechnology(01), Botany (01), Zoology (01), English(09), History(01), Geology(02), Management(04), Ayurvedic(13), Geography(05), Lib. & Inf. Science(01), Law(13), Statistics(01), Hindi(08), Food Sc. & Technology (04), Home Science (05), Computer Science (04), Electronics (02), Commerce (02), Odia (17).

- 2. Entrance / Processing Fee**

The candidates should download the Challan Form (available in the University website: [www.suniv.ac.in](http://www.suniv.ac.in)) and deposit Rs.1500/- in any branch of the State Bank of India towards processing and entrance fee. The Bank will provide a Journal No. against the deposit, which should be given in the application form at the time of online registration.

- 3. Exemption from Entrance Test**

The following categories of candidates shall be exempted from appearing at the Written Test.

- a. Candidates who have qualified in UGC/CSIR(NET), GATE and such examination conducted by ICAR, ICMR and other National Bodies. However, candidates qualifying in UGC/CSIR NET JRF/GATE (All Subjects) / INSPIRE / RGNF or any other similar fellowship at all India level for Ph.D. programme shall be admitted directly on application in plain paper at any time of the year specifying the research interest & area and from among them those not exempted from course work shall take course work in the subsequent year. They shall be admitted irrespective of the stipulated number of research students assigned to the Supervisor or the Department in the concerned subjects. They are advised not to apply through online for the Ph.D. programme and may ignore this advertisement.
- b. Teachers who have a minimum of five years of teaching experience in the +3 Degree Colleges/P.G. Level at the University.
- c. Those who have a minimum of five years of continuous professional experience relating to subject concerned in a managerial cadre / scientist not below a rank of College Teacher.
- d. Candidates having M. Phil. / M.Tech. Degree of Sambalpur University or recognized University with course work.
- e. A candidate who has successfully passed the 1<sup>st</sup> semester course of M.Phil. programme under revised UGC regulation 2009 with a minimum of 6.5 OGPA or 60% in aggregate.

Candidates, not exempted, have to appear at the written test on **26.10.2014 (SUNDAY)** and must secure a minimum of 50% marks in the test, to be eligible for appearing at the Viva-Voce test at the Nodal centre for the subject (5% relaxation in case of SC/ST)

- 4. Exemption from Course Work**

The following categories of candidates shall be exempted from Pre Ph.D. course work.

- (a) Candidates who have passed M.Phil. / M.Tech. in the subject of Ph.D. programme from this University or from other University / Institute recognized by this University and the admission at the M.Phil. / M.Tech. Programme has been through an entrance examination and course work has been prescribed.
- (b) A candidate who has successfully passed the 1<sup>st</sup> semester course of M.Phil. Programme in the same subject under revised UGC regulation 2009 with a minimum of 6.5 OGPA or 60% in aggregate from this University or from other University/Institute recognized by this University.



## 5. Final Selection

The final selection of all qualified candidates shall be based on career (80%) and Viva-Voce (20%) which will be conducted by the respective Nodal Centres on a pre-notified date. All such selected candidates shall be eligible to enroll in Ph.D. Course Work equivalent to 1<sup>st</sup> Semester of M.Phil. in the Nodal Centre. A candidate securing a minimum of 6.5 Grade Point in the Course Work shall be eligible for Ph.D. registration under Sambalpur University.

6. The decision of the University authority shall be final and binding in the interpretation of application and regulation for Ph.D. programme of Sambalpur University
