Media Lab Asia has been set up by the Ministry of Communications & Information Technology, Department of Electronics and Information Technology (DeitY), Government of India, to innovate, develop and deploy ICT and other emerging technologies for the benefit of the common man. The objective of Media Lab Asia is to bring the benefits of Information and Communication Technologies (ICT) and other advanced technologies to the common man. Media Lab Asia was incorporated under Section 25 of the Companies Act, 1956 on September 20, 2001 as a company without having a share capital and limited by guarantee.

Department of Electronics and Information Technology (DeitY), Ministry of Communications and Information Technology, Government of India has initiated a scheme "to enhance the number of PhDs in the Electronic System Design and Manufacturing (ESDM) and IT/IT enabled Services (ITES)". The National Policy on Electronics (NPE 2012) and The National Policy on Information Technology (NPT 2012) give special thrust on significantly increasing the number of PhDs in the country to enable India to compete globally in the coming decades, to develop an ecosystem of research, development and IP creation in these knowledge intensive sectors. There is need for a special programme to create necessary capacities to achieve the target. The scheme proposes to meet these objectives.

The **proposed scheme** is also expected to encourage working professionals and non PhD faculty members to pursue PhD in the ESDM or IT/ITES sectors.

Media Lab Asia has been entrusted with the implementation of the PhD scheme. For implementation of the scheme, a "PhD Cell" has been established to work out the institutional mechanism and to provide secretariat facility and manage activities of the scheme.

Media Lab Asia intends to fill a few Senior technical and Administrative Positions for its PhD Cell, from persons who have excellent background in Electronics System Design and Manufacturing (ESDM) and IT/ IT enabled Services (ITES). The duration of the project would be for nine years. The assignment shall be on contract initially for 2 years & extendable for further terms, two to three years at a time, based on performance & need, co-terminus with the duration of PhD Project. **Private sector professionals and ex-government employees would also be eligible to apply for these positions.**

All positions are on contract appointment basis covering fixed duration and on Consolidated salaries. Your appointment shall be initially on probation for a period of six months with effect from the date appointee joining Media Lab Asia. If it is necessary that more time be needed to assess the performance of the appointee, then the probation period may be extended by Media Lab Asia, at its discretion.
