- 1. Application should be submitted in the prescribed proforma and Separate application should be submitted for each post. Self attested copies of the relevant documents are to be attached with the application such as Educational Qualification/Age Certificate/ Caste Certificate etc.
- Crucial date for determining the upper age limit of candidate will be the closing date of receipt of application. Relexation to SC/ST/OBC as per rules. There will be no age limit for the emplyees of the Council for the above Technical posts. The maximum age limit for the ICAR employees will be relaxable upto 45 years for the post of Stenographer Grade-III.
- 3. Application form must accompany with a Bank Draft of ₹ 500/- for the posts mentioned at serial No. 1 to 3 and ₹ 200/- for the post mentioned at serial No. 4 to 9(SC/ST/Women/Physical Handicapped candidates are exempted) drawn in favour of the Director, VPKAS(ICAR), Almora payble at SBI, Almora. - 6. The posts is temporary but likely to continue and the candidate may be transferred to anywhere in india in ICAR institutes/stations.
- 7. For Research Associates / Senior Research Fellows who have been engaged on contractual basis in different Institutes under ICAR as on i.e. 12.12.2011 are eligible for relaxation in the upper age limit to the extent of their spell, during which they were actually engaged as RAs / SRFs in different projects (maximum of 16 years 3 months). A break of more than 6 months may not be accepted and may be treated as an inordinate spell of break. An employment certificate indicating the names of the project and the exact period the incumbent worked in each project, may be obtained from the Competent Authority, and enclosed alongwith the application. The applications without Experience certificate will be disqualified. The age relaxation is applicable for the posts of T-6, T-4 and T-3 under Direct Recruitment for RAs / SRFs only. This dispensation is only for relaxing the maximum age limit and does not imply any other relaxation whatsoever regarding essential qualifications and experience etc.
- 8. Candidates applying for the vacancies will have to give a declaration stating whether he is related to any employee of the VPKAS(ICAR), Almora or any Institues of ICAR and, if so, name the persons and describe the nature of his/her relationship.
- 9. The prescribed qualifications are minimum and an enhanced qualification does not entitle the candidate to be called for written test/interview. Where the number of applications received in response to advertisement is large, it will not be convenient or possible for the Istitute to call all the candidates for written test/interview.
