Any false claim made by the candidates will be viewed seriously and penal action will be initiated by the Commission against them besides rejection of their applications.

In case of failure to send the documents and/or in case of any rejection of applications, an additional provisional list of candidates to be admitted to the Oral Test will be published. Subsequently, such candidates will

be admitted to Oral Test after verification of documents, to be submitted within the prescribed period.
