ELIGIBILITY

The minimum qualification for admission is a Bachelor's Degree from a recognized university or institution with at least 50% marks or equivalent CGPA (45% in case of SC, ST and Persons with Disability) in agricultural and allied sciences or any other discipline. NRI / PIO / Foreign students can also apply.

SELECTION PROCEDURE

The candidates must have a valid score of CAT / MAT / ATMA / CMAT exam. Selection will be on the basis of academic record, test scores, writing skill, group discussion and personal interview.

RESERVATION

The Reservation for SC / ST / OBC / PWD candidates is applicable as per the Government of India rules, subject to meeting the other eligibility criteria for admission.
