<u>Note 2</u>: Candidates belonging to reserved categories meeting the cut-off fixed for UR category are shown in their respective category.

<u>Note 3</u>: If there is no reported vacancy in OBC/SC/ST/Ex.S/OH/HH/VH category, candidates belonging to these categories have been considered in Paper-II at cut-off fixed for UR.

<u>Note 4</u>: As per Notice of Examination, candidates intending to apply for the post in more than one State/UT had to submit separate applications for each State/UT to the Regional Office having jurisdiction over such State/UT. Therefore, only those candidates who had applied to the concerned Regional Office having jurisdiction over the concerned State/UT were considered.

- 4. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as policy of the Govt., the category status is indicated against their Roll No. It is important to note that some of them have been declared qualified only in the category mentioned against their Roll Nos. If any candidate does not actually belong to the category mentioned against him/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to contact immediately to the Regional Director(SR) in all such cases where they do not belong to the category shown against their Roll Nos.
- 5. Document verification of the shortlisted candidates (Paper-II) is scheduled to be held at Regional Office (SR), Chennai from 29.09.2014 to 01.10.2014. Final result will be declared after completion of document verification.
