However, in the case of candidates belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes, the upper age-limit relaxation shall be the same as prescribed by the State Government for entry into similar services for such candidates.

Candidates fulfilling the above conditions may apply for the post along with supporting documents, duly attested by a Gazetted Officer and 3(three) recent passport size photographs, to the undersigned. Applications received without supporting documents and photographs will be summarily rejected. **Candidates are also required to mention their proper address and mobile/contact numbers in their applications**.
- 5. The last date for receipt of applications is 07.08.2017.
- 6. Applications received after the last date shall not be entertained on any ground.
- 7. Those who are already in Government service shall apply through proper channel.
- 8. Candidates found eligible on preliminary scrutiny of the applications shall be issued admit cards for appearing in the practical test/written examination. The list of names of candidates found eligible will be displayed on the Notice Board of the High Court of Sikkim and/or the eligible candidates will be intimated through sms in their mobile numbers mentioned in their applications along with the details of the written/practical/viva-voce tests.
