2. **JOURNEYMAN:**

- i) The method of selection will be based on the Written Test of 80 marks followed by Practical Test / Trade Test of 20 marks.
- ii) Based on the performance in the written Test and merit, the candidates will provisionally be shortlisted for Practical Test / Trade Test.

3. **APPLICATION FEE:** Not applicable

4. **GENERAL INFORMATION:**

- i) Written Test and Practical / Trade Test (as applicable) will tentatively be held on **28 Oct 2017** & **29 Oct 20107** respectively at Kolkata.
- ii) Please note that candidature of the candidate is liable to be cancelled if he / she submits more than one application for same post.
- iii) Persons with Disability category are required to produce Medical Certificate in prescribed format issued by the Competent Authority as stipulated in Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 having minimum 40% or more disabilities in the category of OH / HH / VH as the case may be.
- iv) SC, ST & OBC (NCL) candidates are required to produce a caste certificate only in the prescribed format issued by Competent Authority.
- v) Candidates serving in Government / Quasi Government offices, Public Sector Undertakings are instructed to submit their application through proper channel. In case, he sends an advance copy of the application, he will have to submit a "No Objection Certificate" from his / her employer at the time of document verification / Trade Test, failing which the candidature will not be considered.
