PROBATION&SERVICE BOND

In the event of his /her resignation from the post before this period, the AGM / Manager will be required to indemnity and refund the bond amount to the Company.

SUBMISSION OF ONLINE APPLICATION:

Candidates are once again requested to read the contents of the advertisement and ensure their eligibility before applying.
