## Notification for engagement of Apprentices under Apprentices Act, 1961

1. Container Corporation of India Ltd., a 'Navratna' Central Public Sector Enterprise under Ministry of Railways, proposes to engage Apprentices under Apprenticeship Act 1961 for training at CONCOR Offices.

2. Applications are invited from eligible candidates in designated trades for engagement as Apprentices under Apprenticeship Act 1961 read in conjunction with Apprenticeship Rules 1992 & Apprentices Amendment Act 2014.

3. Reservation in Training: Government of India guidelines in Reservations will be followed.

### 4. Eligibility Criteria:

- A. **Qualifications:** Prescribed qualification as mentioned above or amended thereof, if any, with a minimum of 50% marks in qualifying exams.
- B. **Age:** The candidate should have attained the age of 14 years & should not have attained the age of 21 years as on 01.10.17. Age relaxation to SC/ST/OBC/PWD candidates applicable as per Govt. guidelines.
- C. **Minimum Physical standards:** As prescribed in the Apprenticeship Rule 1992, Clause- 4 and Amendments thereof, if any.
- D. **Previous Training:** Candidates who have already undergone or are currently undergoing Apprenticeship training under Apprenticeship Act 1961 in any Government or Pubic Sector or Private Industrial Organization are not eligible to apply.
- E. The applicant should not have undergone apprenticeship training earlier or pursuing apprenticeship training as per the Apprentices Act, 1961 /1973 as amended from time to time.
- F. The applicant should not have completed 3 years after passing the qualifying examination as on 01.10.17.
- **5**. **Stipend:** Monthly stipend will be paid as prescribed above.
- **6. Duration of Training**: The duration of training as mentioned above, however, the actual training period will be as per the prescribed training duration, governed by Apprenticeship Act.
- **7. Selection Procedure**: The selection of the applicants will be done through Interview.
- **8. TA-DA, Boarding/Lodging Expenses:** No TA-DA/Boarding /Lodging expenses are admissible.
- 9. Application is to be submitted with the following documents duly attested by the candidate:
  - a) Passport size photographs 5 nos.
  - b) 10th Class/SSC/Matriculation Mark-sheet.
  - c) ITI Certificate & Mark-sheet (if applicable)
  - d) 12th Class/HSC Mark Sheet (if applicable)
  - e) Degree Certificate & Mark-sheet, if applicable
  - f) Proof of Date of Birth.

- g) Caste Certificate (SC/ST/OBC) if applicable.
- h) Certificate of Physical Disability, if applicable.
- i) Character Certificate signed by Gazetted Officer/issued by College Authorities.
- j) AADHAAR Card (Compulsory).
- k) Details of AADHAAR linked Bank Account.
- **10. Incomplete/Erroneous Applications** will be rejected. No further communication will be entertained in this regard.
- 11. Medical Fitness Certificate: Candidates will have to submit Medical Fitness Certificate obtained from a Govt. Medical Officer not below the rank of Assistant Surgeon (Gazetted). The medical officer shall certify that the applicant is fit to join in the trade for which application is being made in terms of Apprenticeship Rule 1992, Clause- 4 and Amendments thereof, if any. Physically handicapped candidates shall by either the medical board attached to Special Employment Exchanges for the physically handicapped or the local Civil Surgeon (where such Medical Board has not been constituted) to be physically fit for being engaged as an apprentice in the trade for which application is being made.

#### 12. Registration and Submission of Applications:

- Candidates willing to take ITI Trade Apprentice Training at CONCOR are first required to register in the web portal <a href="http://apprenticeship.gov.in">http://apprenticeship.gov.in</a> for enrolment as apprentices. The application will not be accepted without registration in the above mentioned web portal.
- The candidates have to apply for the respective trade through the Establishment ID.
- Establishment ID for CONCOR is **E10160700100** for www.apprentice.gov.in
- Candidates are required to download the application format (Annex.-I) and forward their duly filled-in application along with all documents (self-attested) as mentioned above to the following address by Speed Post or Regd. Post AD only. By hand applications will not be accepted / entertained.
