Applications are invited in plain paper from citizens of India for filling up the following various posts in District Mental Health Program, Govt. of Arunachal Pradesh, Naharlagun under the National Mental Health Program on contractual basis under the terms of the relevant rules of "Contractual Service" for a period up to 31<sup>st</sup> March'2018(likely to be extended depending upon the performance, continuation and extension of the program)at a consolidated pay under District Mental Health Program, Govt. of Arunachal Pradesh. Clinical Psychologist	PG Degree in Psychology or applied Psychology or Master of Philosophy in Medical and Social Psychology or Master in Philosophy in Mental Health and Social Psychology obtained after completion of a full time course of two years which includes supervised clinical training approved and recognized by the Rehabilitation council of India.
3.	Psychiatric Social Worker	M. Phil in Psychiatric Social Work with minimum 2 (Two) years experience in Mental Health or Psychiatric Social Work
4.	Psychiatric Nurse	B.Sc. nursing or equivalent degree from institutions recognized by Nursing Council of India and at least 2 years experience of working in Psychiatry/Mental Health Institutions/Hospital. <b>Desirable-</b> PG Diploma in Psychiatric Nursing from institutions recognized by Nursing Council Of India.

### Method of Selection

The eligible candidate will have to appear in a written examination followed by the viva voce/interview to be conducted by the department. In the written examination there will be one question paper for each post for 100 Marks and each paper will contain 50 objective type questions carrying 2(Two) marks each. Each paper will cover concern subject, Current affairs, General English. There will be no negative marking. To qualify the candidates have to secure **50% mark**. The number of the candidates who shall be called for Viva Voce will be in the ratio of **1: 3** i.e three candidates for one post as per merit in written examination.

**GENERAL CONDITIONS AND INFORMATION:**

1. The application should reach in this office of State Program Officer, Mental Health Program, Directorate of Health Services, Naharlagun latest by on or before **30th October'2017, 4.00 PM.**
2. Incomplete application or those received after the expiry of the last date will be rejected and no correspondences will be entertained.
3. Any application or representation submitting before the interview is not to be entertained. All those candidates who have applied before on their own or otherwise need to apply a fresh.
4. Reservation norms for APST candidate will be followed as per Govt. norms.
5. The applicants shall have no claim in future for regular appointment in the post after selection.
6. Only one application will be entertained of each candidate for a single post. Multiple applications for various posts by the same candidate will be rejected.
7. No individual call letter for written examination/Viva voce will be issued to any candidate.
8. Candidates selected shall execute an undertaking to serve at any district of Arunachal Pradesh
9. No TA/DA will be admissible for appearing the interviews.
