Vacancy reserved for Ex-Serviceman (ESM) will be filled up from any category and then be adjusted horizontally against respective categories viz UR/SC/ST/OBC as the case may be depending upon the category to which the selected candidate belongs to, that means the vacancy earmarked for Ex-serviceman is included within the total vacancies of 16 posts of Drivers.

SCALE OF PAY OF STAFF CAR.DRIVER : Rs, 19900/- (Level 2 in the pay Matrix as per 7th CPC)

PERIOD OF PROBATION : Two years for direct recruits.

LAST DATE FOR RECEIPT OF APPLICATION : On or before 22.01.2018 by 1700 Hours.

1. Eligibility

a) **Age Limit for direct recruits** : 18 to 27 yrs [Relaxable 5 yrs for SC & ST, 3 yrs for OBC , for Government Servants upto 35 yrs in accordance with the instructions or orders issued by Central Government and for Ex – Serviceman upto a maximum of 3 years [08 (3+ 5) years for SC & ST and 06 (3+3) years for OBC] after deduction of the Military Service rendered from the actual age].

The crucial date for determining age limit shall be the closing date for receipt of applications from candidates in India.

b) **Educational & Other qualifications for direct recruits:**

- Possession of a valid driving licence for light & heavy motor vehicles.
- Knowledge of Motor Mechanism (The candidate should be able to remove minor defects in vehicle)
- Experience of driving light & heavy motor vehicle for at least three years.
- Pass in 10th Standard from a recognized Board or Institute. And

c) **Desirable qualification:** Three years' service as Home Guard or Civil Volunteers.

2. Selection

Selection of Driver shall be made on the basis of driving test to assess their competency to drive light and heavy motor vehicles, from amongst the candidates possessing the requisite eligibility criteria mentioned above. The date and venue of the tests will be intimated separately to the eligible candidates. **No intimation will be sent in respect of other applicants who are not eligible.**
